
# POSTGRADUATE STUDIES IN PHYSICAL EDUCATION MASTER'S DEGREE



The Coordination of the Postgraduate Program in Physical Education, offered in full association by the Department of Physical Education of UFV and the Faculty of Physical Education and Sports of UFJF, announces that applications will be open for the selection of candidates for the Master's Degree Course, from **July 11 to August 11, 2024**, to begin in the second semester of 2024.

The Postgraduate Program in Physical Education is structured in the Area of Concentration entitled "Exercise and Sport", with the following lines of research:

# a) Physical activity and health.

Study of the effects of physical activity and sedentary lifestyle in different population groups.

## b) Studies of sport and its manifestations.

The study of physiological, sociocultural, historical and psychological aspects and how they affect or are affected by sport.

# **MASTER'S SELECTION PROCESS**

# 1. Target audience

For the Master's degree course: holder of an undergraduate diploma or equivalent document (see item 7 of this Notice), issued by a course recognized by the Ministry of Education or a duly revalidated foreign diploma.

# 3. Registration

The candidate's registration implies knowledge and tacit acceptance of the rules and conditions contained in this notice, in relation to which he/she may not claim ignorance.

Twenty percent (20%) of the total number of places will be reserved for affirmative action. Any vacancies not taken up under the affirmative action scheme will be reallocated to the open competition scheme.

Registration for the selection process will be carried out via the internet on the UFV postgraduate registration system website (GPS): https://gps.ufv.br/gps-web/editais/879/

Only registrations made online as indicated and with the appropriate payment of the registration fee will be accepted. The fee must be paid using the bank payment slip that will be generated automatically at the time of registration and must be paid within one (1) working day of the end of registration. Confirmation of payment is automatically acknowledged in the system itself, but it is advisable to keep the receipt if requested.

Candidates should note that online registration takes place in two stages:

Step 1: Saving the registration: The data is saved in each form launched on the screen. At the end of registration, a completion password will be sent to the registered e-mail address.

Step 2: Finalizing the registration: Entering all the data is mandatory and, once finalized, editing is no longer permitted.

After completing Stage 2, it is important that the candidate accesses their application again and checks the integrity of the documents uploaded. If you encounter any problems, please contact the graduate program office (ppgefi@ufv.br).

When registering, the candidate must choose one of the modalities, as described below:

- 1. Broad competition
- 2. Places reserved for affirmative action
- 2.1 Black or indigenous candidates;
- 2.2 People with disabilities.

To apply for the places reserved in Mode 2.1, the candidate must fill in and sign the ethnic-racial self-declaration form, which is available on the online application form, and present themselves to the Commission for the Validation of the Self-Declaration of Black, Brown or Indigenous Candidates, for hetero-identification, in the case of self-declared black and brown candidates, and for verification of supporting documentation, in the case of indigenous candidates, in accordance with the provisions of Resolutions No. 10 of 2018 and No. 8 of 2019. To apply for the places reserved in Modality 2.2 and 2.3, the candidate must fit into the categories listed in Article 4 of Decree No. 3 298 of 1999 and submit a medical report attesting to the type and degree of disability, with

4 of Decree No. 3.298 of 1999 and submit a medical report attesting to the type and degree of disability, with express reference to the corresponding code of the International Classification of Diseases (ICD) and the tests proving their disability, in accordance with the provisions of Resolutions No. 10 of 2018 and No. 8 of 2019. The supporting documentation will be presented to a Disability Assessment Committee, under the terms of Article 4 of Decree No. 3.298 of 1999, which will issue an opinion on the candidate's eligibility or ineligibility for the reserved seat.

The order of presentation to the Committees will be, depending on the case: (i) Self-declaration Validation Committee and (ii) Disability Determination Committee.

People with disabilities must inform the Graduate Program at the time of registration so that accessibility and other conditions that enable them to participate equally in the selection are provided.

#### Application period: July 11 to August 11, 2024.

  - o Legible copy of the undergraduate transcript;
  - Copy of the Curriculum Vitae, with the respective copies of the supporting documents. The CV
    must be structured with the same items and in the same sequence as the criteria presented for
    scoring the CV described in item 5, Third Stage, of this Notice;
  - o Legible copy of birth certificate or copy of marriage certificate if married;
  - o Legible copy of ID card;
  - Legible copy of CPF;
  - o Legible copy of the Military Service Document (reservist) for male candidates;

  - Legible copy of the Research Project. The Research Project must follow the instructions described in item 8 of this Notice. Failure to submit the research project in accordance with the notice will disqualify the candidate.
  - o Self-declaration of candidates for places reserved for black and indigenous people;
  - o Indigenous Birth Certificate and/or Letter of Recommendation issued by a recognized indigenous leader, recognized indigenous elder, indigenous personality of recognized public repute or indigenist body and/or transcripts issued by an indigenous school; Indigenous Education Memorial (description of indigenous educational pathways, indicating the level of appropriation of the indigenous language), in the case of candidates for places reserved for indigenous people.
  - o Medical report and supporting exams (with report) carried out in the last 12 months, in the case of candidates for places reserved for people with disabilities.

- Legible copy of the Research Project. The Research Project will follow the script described in item 8 of this Notice;
- Self-declaration of candidates for places reserved for black and indigenous people;
- Indigenous Birth Certificate and/or Letter of Recommendation issued by a recognized indigenous leader, recognized indigenous elder, indigenous personality of recognized public repute or indigenist body and/or transcripts issued by an indigenous school; Indigenous Education Memorial (description of indigenous educational pathways, indicating the level of appropriation of the indigenous language), in the case of candidates for places reserved for indigenous people;

• Medical report and supporting exams (with report) carried out in the last 12 months, in the case of candidates for places reserved for people with disabilities.

#### **Exemption from the registration fee:**

The application for exemption from the registration fee must be made on the selection process registration site itself by the 5th (fifth) registration day of the schedule, attaching a copy of the Single Registry Summary Sheet - V7.

The other rules will be as stipulated in the General Notice of Enrollment in UFV's Stricto Sensu Postgraduate Programs:

- a) In accordance with Law 12.799/2013, candidates who:
- i) belongs to a family registered in the Federal Government's Single Registry for Social Programs (CadÚnico), whose monthly family income per capita is less than or equal to half a national minimum wage;
- ii) Is a bone marrow donor in entities recognized by the Ministry of Health.

The exemption must be requested at the time of registration directly to the selected Program.

UFV will consult the Cad-Único management body to verify the veracity of the information provided by the candidate regarding item "i". False information will result in the annulment of the registration for fraud and the candidate will bear the following costs

with the resulting legal consequences.

Candidates requesting exemption from the fee mentioned in item "ii" must upload a scanned copy of the following documentation: a certificate or report issued by a doctor recognized by the Ministry of Health, registered with the Regional Medical Council, proving that the candidate has donated bone marrow.

The application for exemption from the registration fee will be evaluated by the Coordinating Committee of the Postgraduate Program.

The result of the exemption request will be informed to the candidate on the Program's website (https://ppgefi.ufv.br/) and will be available at the secretariat. UFV is not responsible for other forms of publication and/or information on the result.

It is the candidate's sole responsibility to find out the outcome of the exemption.

Candidates who comply with the provisions of paragraphs i and ii and have their request for exemption denied may appeal the decision to the Coordinating Committee of the Postgraduate Program in Physical Education. The results of the appeals will be published by the secretariat on the program's website (https://ppgefi.ufv.br/). If the application is rejected, the candidate will have 24 hours to appeal the decision. This request will be reevaluated and the result will be published by the secretariat on the program's website (https://ppgefi.ufv.br/). If the application is rejected, the candidate will have until the 15th (fifteenth) registration day of the timetable to pay the fee, using a slip of paper generated on the selection process registration website.

**Application approval:** After analyzing the documentation submitted, the Coordinating Committee of the Postgraduate Program in Physical Education will decide whether to approve the application, and the result will be published on the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br, within 5 (five) days of the end of the application period. Only applications that meet the requirements of this Notice will be accepted. Applications that are incorrectly filled in or lack mandatory documentation will not be accepted.

#### 2. Board of Examiners

The examining board for the selection process will be made up of two (2) permanent professors from the Graduate Program in Physical Education at UFV/UFJF and will be announced on the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br, within two (2) days of the end of the registration period. In the event that the candidate identifies any link that may corrupt the impersonality of the examination board, he/she must file an appeal within 24 hours of its publication. The examining board will evaluate candidates in all stages of the selection process and will respond to appeals filed by candidates after the preliminary results of each stage have been announced. At all stages, candidates will be identified by an individual code generated after registration, and will no longer be identified by name or CPF.

#### 3. Selection

#### The selection process will consist of the following stages:

#### First Stage - Eliminatory and Qualifying

Evaluation of the Research Project in written form by an examining board made up of 2 (two) professors, with a score of 0 to 100 points, eliminatory for a score of less than 70.0 points and classificatory for a score of 70.0 points or more.

The evaluation will be based on the following criteria: 1) Theoretical foundation; 2) Objectives and/or hypotheses; relevance/adequacy of bibliographical references, timetable, financial viability; 3) Quality and feasibility of the method; and 4) Suitability of the project to the research lines of the program and the intended advisor (attach a letter to the project clearly explaining this point). Each evaluation criterion presented will be worth 100.0 points and the final score for this item will be calculated as the arithmetic mean of the scores obtained for each evaluation criterion for each professor. Projects that do not fit in with the research line of the intended supervisor will be disqualified.

The results of the first stage will be published on the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br together with the day and time of the individual hearing of those approved for the second stage of the selection process.

Announcement of the results of the first stage: The results of this stage will be published within 14 (fourteen) days of the application being accepted on the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br.

#### **Second Stage - Elimination and Classification**

Oral exam (on the topic informed by each advisor in item 9 of this notice) and online discussion of the Research Project and mastery of topics related to the lines of research of the intended advisors (see item 9 of this notice), with a score of 0 to 100 points, eliminatory for a score of less than 70.0 points and classificatory for a score of 70.0 points or more. It will be carried out by an examining board made up of two (2) teachers.

Candidates must be available online half an hour before the scheduled time of their hearing and have access to a computer equipped with a camera, microphone and internet connection to ensure their participation in the process without interruption. The candidate must present an original photo ID before the start of this stage.

The hearing will be held via the *google meet* platform. The link to access the online hearing room will be sent by e-mail to the candidate by the advisor chosen during registration.

In the event of a candidate's non-attendance, i.e. if they do not access the online meeting room at the time set for the online examination of their Research Project, they will be disqualified from the selection process. The hearing will be recorded and its storage will be guaranteed.

The candidate will be asked about the Research Project using the following criteria: 1) Theoretical basis; 2) Objectives and/or hypotheses; 3) Quality and feasibility of the method; 4) Up-to-date bibliographical references; 5) Timetable; 6) Financial viability; 7) Skills and abilities for carrying out the proposed Research Project; 8) Adequacy of the project with the research lines of the program and the intended advisor. Each evaluation criterion presented will be worth 100 points and the final mark for this item will be calculated as the arithmetic mean of the marks obtained for each evaluation criterion.

Announcement of the results of the second stage: The results of this stage will be published within 14 (fourteen) days of the application being accepted on the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br.

#### **Third Stage - Qualifying**

Assessment of the Curriculum Vitae by an examining board made up of two (2) professors. The organization of the CV must follow the guidelines described below, and candidates who fail to do so will be disqualified. The supporting documents must be attached in the same sequence as the Curriculum Vitae. The Curriculum Vitae will be structured and scored according to the following criteria:

Education (Total of up to 30.0 points):

- 1.1- Doctorate (30.0 points each).
- 1.2- Master's degree (20.0 points).
- 1.3- Postgraduate Lato Sensu (5.0 points each).
- 1.4- Scientific Initiation Scholarship (5.0 points each).
- 1.5- Monitoring (2.0 points each).
- 1.6- Extension or PET scholarship (3.0 points each).

Research Activities - papers published and/or accepted for publication (Total of up to 40.0 points): Note:

Only the last five years will be considered for item 2.

- 2.1- Scientific articles in indexed journals [10, 9, 8, 7, 6, 5, 4, 3 points each, respectively for articles classified in the most current *Webqualis* list (2017-2020 Quadrennium); Physical Education Assessment Area, as A1, A2, A3, A4, B1, B2, B3 and B4. When the candidate is first author, he/she will receive a bonus of 50% of the points.
- 2.2- Full scientific articles in conference proceedings (0.5 points each).
- 2.3- Abstracts in periodicals and conference/symposium proceedings (0.25 points each, totaling up to 2.0 points).
- 2.4- Book chapter (4.0 points each, totaling up to 20.0 points).
- 2.5- Book (10.0 points each, totaling up to 20.0 points).
- 2.6 Coordinator of a research group with CNPq certification (5.0 points).

2.7- Undergraduate and/or Specialization Course Conclusion Work (1 point per work, totaling up to 5.0 points).

#### Extension Activities (Total of up to 20.0 points):

- 3.1- Courses and lectures given (2.0 points each, totaling up to 10.0 points).
- 3.2- Participation in courses, congresses, symposia, lectures or similar (0.5 points each, totaling up to 10.0 points).

<u>Professional Activities</u> (Total of up to 10.0 points):

- 4.1- Teaching in higher education (1.0 point for every 15 hours, totaling up to 10.0 points).
- 4.2- Teaching in primary and secondary schools and technical courses (1.0 point per year, totaling up to 5.0 points).

<u>Completed Score Sheet</u> - fill in the score sheet in Annex I, at the end of the Notice (failure to submit this sheet duly completed will disqualify the candidate).

#### 6. Final Score and Ranking

The final grade will be calculated from the sum of the three stages of the selection process (Stage 1 + Stage 2 + Stage 3) and published by name on the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br, within 14 (fourteen) days of the third stage. The final ranking will be from the highest to the lowest score.

- · In the event of a tie between two or more candidates, the tie-breaker will be the highest score obtained in the First Stage.
- The list of successful candidates will be made up of the first candidates to fill the vacancies of the advisor indicated on the application form.
- The surplus list will be made up of candidates who have qualified but exceeded the number of places offered by the advisor indicated on the application form.

The Postgraduate Program in Physical Education is not obliged to fill all the places on offer.

#### 7. Registration

The successful candidate must submit their documentation for registration and subsequent enrollment after the final ranking has been announced, as soon as requested, to the Postgraduate Department in Physical Education at the Faculty of Physical Education and Sports at UFJF (for successful candidates under the supervision of a professor working at UFJF) or to the Postgraduate Department in Physical Education at the Department of Physical Education at UFV (for successful candidates under the supervision of a professor working at UFV). Any successful candidate who fails to submit the documentation within this period will be considered to have withdrawn and, consequently, the subsequent candidate from the list of surplus candidates per supervisor will be called.

The respective Secretariats will send an e-mail advising those approved on how to deliver/send the documents required for registration. Candidates on the reserve list, if called by e-mail and/or telephone and/or via the websites www2.ufjf.br/pgedufisica and www.ppgefi.ufv.br, must deliver/submit their documents to the Postgraduate Department in Physical Education at the Faculty of Physical Education and Sports at UFJF (for successful candidates under the supervision of a lecturer linked to their place of work at UFJF) or to the Postgraduate

Department in Physical Education at the Department of Physical Education at UFV (for successful candidates under the supervision of a lecturer linked to their place of work at UFV).

Candidates will be enrolled once the final results have been announced. The subjects to be taken must be agreed between the candidate and their supervisor. If there are no subjects available until the beginning of the following semester, the student must enroll in "Research".

Legible copy of the Protocol of Presentation to the Federal Police.

Foreign applicants who have been approved under the supervision of a lecturer linked to their place of work at UFV must present a registration authorization document provided by UFV's Directorate for International Relations (DRI).

Documents required for entrants in the "Black (black and brown) or indigenous candidates" and "Black (black and brown) or indigenous and disabled candidates" categories:

- i. Ethnic-racial self-declaration, completed and signed;
- ii. For indigenous candidates:

- a) Indigenous birth registration and/or letter of recommendation issued by a recognized indigenous leader, recognized indigenous elder, indigenous personality of recognized public reputation or indigenous body and/or transcripts issued by an indigenous school; or
- b) Memorial of Indigenous Education (description of indigenous educational pathways, indicating the level of appropriation of the indigenous language), in the case of candidates for places reserved for indigenous people. Documents required for entrants in the "Person with a disability" category and for "Black (black and brown) or indigenous candidates with a disability":
- i. Medical report;
- ii. The following medical examinations to prove disability:
- a) Hearing impairment: audiometry test;
- b) Visual impairment: ophthalmological examination;
- c) Physical disability: imaging tests or other tests proving the disability;
- d) Multiple disabilities: tests to prove the disabilities, according to the areas affected.

**Note:** Failure to present any of the documents described above will make it impossible to register for the program.

#### 8. Guide to setting up a research project

Candidates must submit a Research Project that is in line with the research line of the intended advisor (see Lattes curriculum vitae). The Project must follow the following guidelines and be limited to a maximum of 7 (seven) pages typed on A4 paper, *Times New Roman* font size 12, 1.5 spacing:

#### Cover

- Project title.
- CPF of the candidate, without identifying the name.
- Name of the supervisor to whom the project will be submitted.

Note: The cover does not count towards the page limit.

#### 1. Introduction

Give a brief account of the problem-situation you are addressing, citing data or information that can define its context. Substantiate your defense and line of action/theme (What?; Why?). Present an up-to-date bibliographical review that objectively justifies the implementation of the proposal.

#### 2. Objectives

State the objectives to be achieved by the project.

#### 3. Methods

Explain how you intend to achieve your objectives (subjects, procedures and statistical treatment). In addition, the timetable and financial viability should be described.

#### 4. References

List the sources cited in the body of the project

**Note**: References do not count towards the page limit. Consider 30 to be the maximum number of references that should be cited in the project. In addition, annexes do not count towards the page limit.
